1 Model Description

1.1 Problem Statement

The following derivation is a shortened version from Reference.¹ To help define the problem, Figure 1 is displayed. This problem involves a spacecraft consisting of a hub which is a rigid body and has a center of mass location labeled as point B_c . The hub has M number of tanks and N number of thrusters attached to it. The figure only shows one tank and one thruster but the analytical development is general. The i_{th} tank has a center of mass location labeled as F_{c_i} and the j_{th} thruster is located at B_j . The body fixed reference frame $\mathcal{B}: \{\hat{b}_1, \hat{b}_2, \hat{b}_3\}$ with origin B can be oriented in any direction and point B can be located anywhere fixed to the hub. This means that point B and the center of mass location of the spacecraft, C, are not necessarily coincident. As a result, the vector c defines the vector pointing from the body frame origin to the center of mass fo the spacecraft. The inertial reference frame $\mathcal{N}: \{\hat{n}_1, \hat{n}_2, \hat{n}_3\}$ is centered at N and is fixed in inertial space.

Throughout this paper, vector calculus is used and the notation to define certain quantities needs to be introduced. A position vector, $r_{C/N}$, is the vector pointing from N to C. $\omega_{\mathcal{B}/\mathcal{N}}$ is the angular velocity of the \mathcal{B} frame with respect to the \mathcal{N} frame. \dot{r} denotes an inertial time derivate of vector r and r' defines a time derivate of r with respect to the body frame. Using these definitions, the following describes the Reynolds transport theorem used in this formulation.

1.2 Equations of Motion

1.2.1 Reynolds Transport Theorem and Continuity Equation

In this section the main tool used for the development of the governing equations is presented and explained. The Reynolds transport theorem provides a basic tool to pass from a Lagrangian formulation, based on the analysis of particles moving in space, to an Eulerian one, which considers a fixed space volume where physical quantities are exchanged through the boundaries. In the present document, the Lagrangian system is labeled *Body*, the moving volume of the Eulerian approach is labeled \mathcal{V}_{sc} and its surface \mathcal{A}_{sc} are represented in Figure 2.

By using this notation, the Reynolds transport theorem affirms:

$$\frac{\mathcal{D}_{\mathsf{d}}}{\mathsf{d}t} \int_{\mathsf{Body}} \rho \, \boldsymbol{f} \mathsf{d}\mathcal{V} = \frac{\mathcal{D}_{\mathsf{d}}}{\mathsf{d}t} \int_{\mathcal{V}_{\mathsf{sc}}} \rho \, \boldsymbol{f} \mathsf{d}\mathcal{V} + \int_{\mathcal{A}_{\mathsf{sc}}} \rho \, \boldsymbol{f} \left(\boldsymbol{v}_{\mathsf{rel}} \cdot \hat{\boldsymbol{n}} \right) \mathsf{d}A \tag{1}$$

where f is a general vectorial quantity transported out from the control volume, ρ is the density of the infinitesimal mass dm, \hat{n} the surface normal considered positive if exiting from the control volume, \mathcal{D} is a generic reference frame and v_{rel} is the relative velocity of the particles flowing out from the surface with respect to the control surface itself. This last quantity can be easily defined as $v_{\text{rel}}(x,t) = \frac{\mathcal{D}_d}{dt} r_{M/B}(x,t) - v_{\text{surf}}(x,t)$ where $\frac{\mathcal{D}_d}{dt} r_{M/B}(x,t)$ is the particles' velocity with respect to the \mathcal{D} frame and $v_{\text{surf}}(x,t)$ is the control surface velocity with respect to the \mathcal{D} reference frame. Moreover, if the control volume is fixed in the \mathcal{D} frame and a no deformable control volume is considered,

the following relation is proved:

$$\frac{\mathcal{D}_{\mathsf{d}}}{\mathsf{d}\,t} \int_{\mathsf{Body}} \rho\,\boldsymbol{f} \mathsf{d}\mathcal{V} = \int_{\mathcal{V}_{\mathsf{sc}}} \frac{\mathcal{D}_{\partial}}{\partial\,t} \left(\rho\,\boldsymbol{f}\right) \mathsf{d}\mathcal{V} + \int_{\mathcal{A}_{\mathsf{sc}}} \rho\,\boldsymbol{f}\left(\frac{\mathcal{D}_{\mathsf{d}}}{\mathsf{d}t}\boldsymbol{r}_{M/B}\right) \cdot \hat{\boldsymbol{n}}\,\mathsf{d}A \tag{2}$$

An additional key equation that is used throughout the paper is the continuity equation. First, the continuity equation is gathered:



Fig. 2: Division of the total system in spacecraft and exhausted gas. The control surface A_{sc} represents the exchanging surface between the two subsystems.

$$\frac{\mathcal{B}_{\mathsf{d}}}{\mathsf{d}t} \int_{\mathsf{Body}} \rho \,\mathsf{d}m = \frac{\mathcal{B}_{\mathsf{d}}}{\mathsf{d}t} \int_{\mathcal{V}_{\mathsf{sc}}} \rho \,\mathsf{d}\mathcal{V} + \int_{\mathcal{A}_{\mathsf{sc}}} \rho \,\mathbf{r}'_{M/B} \cdot \hat{\mathbf{n}} \,\mathsf{d}\mathcal{A} = 0 \tag{3}$$

Thus, by defining $\dot{m}_{\rm sc} = \frac{\mathcal{B}_{\rm d}}{{\rm d}t}\int_{\mathcal{V}_{\rm sc}}\rho\,{\rm d}\mathcal{V}$:

$$\dot{m}_{sc} = -\int_{\mathcal{A}_{sc}} \rho \, \mathbf{r}'_{M/B} \cdot \hat{\mathbf{n}} \, \mathrm{d}\mathcal{A} \qquad \Rightarrow \qquad \mathrm{d}\dot{m} = \rho \, \mathbf{r}'_{M/B} \cdot \hat{\mathbf{n}} \, \mathrm{d}\mathcal{A}$$

This definition will be used in the derivation of the EOMs. The translational EOM is developed in the following section.

1.2.2 Translational Equation of Motion

The derivation of the translational EOM must begins considering Newton's law for a closed system:

$$\frac{^{\mathcal{N}}\mathsf{d}}{\mathsf{d}\,t}\int_{\mathsf{Body}}\dot{\boldsymbol{r}}_{M/N}\,\mathsf{d}m=\boldsymbol{F}_{\mathsf{ext}} \tag{5}$$

where $\dot{r}_{M/N}$ is the velocity of the particle at the M point expressed with respect to the inertial reference frame and F_{ext} is the sum of the external forces experienced by the body.

As the total mass of the system is constant, the differentiation operator is brought inside the integration:

$$\frac{N_{\mathsf{d}}}{\mathsf{d}\,t} \int_{\mathsf{Body}} \dot{\mathbf{r}}_{M/N} \, \mathsf{d}m = \int_{\mathsf{Body}} \ddot{\mathbf{r}}_{M/N} \, \mathsf{d}m \tag{6}$$

The acceleration of the origin of the \mathcal{B} frame is expressed as:

$$\ddot{\boldsymbol{r}}_{M/N} = \ddot{\boldsymbol{r}}_{B/N} + \ddot{\boldsymbol{r}}_{M/B} \tag{7}$$

By using the kinematic transport theorem, the expression of $\ddot{r}_{M/B}$ is found:

$$\dot{\boldsymbol{r}}_{M/B} = \boldsymbol{r}_{M/B}' + \boldsymbol{\omega}_{\mathcal{B}/\mathcal{N}} \times \boldsymbol{r}_{M/B}$$

$$\ddot{\boldsymbol{r}}_{M/B} = \boldsymbol{r}_{M/B}'' + 2\,\boldsymbol{\omega}_{\mathcal{B}/\mathcal{N}} \times \boldsymbol{r}_{M/B}' + \dot{\boldsymbol{\omega}}_{\mathcal{B}/\mathcal{N}} \times \boldsymbol{r}_{M/B} + \boldsymbol{\omega}_{\mathcal{B}/\mathcal{N}} \times \left(\boldsymbol{\omega}_{\mathcal{B}/\mathcal{N}} \times \boldsymbol{r}_{B/M}\right) \tag{9}$$

A Lagrangian formulation of the linear momentum equation is deduced by using Equations (5), (6), (7) and (9):

$$\int_{\text{Body}} \left(\ddot{\boldsymbol{r}}_{B/N} + \dot{\boldsymbol{\omega}}_{B/N} \times \boldsymbol{r}_{M/B} + \boldsymbol{\omega}_{B/N} \times \left(\boldsymbol{\omega}_{B/N} \times \boldsymbol{r}_{M/B} \right) \right) dm + 2 \boldsymbol{\omega}_{B/N} \times \int_{\text{Body}} \boldsymbol{r}'_{M/B} dm + \int_{\text{Body}} \boldsymbol{r}'_{M/B} dm = \boldsymbol{F}_{\text{ext}} \quad (10)$$

The system mass is constant, therefore the derivative operator can be applied after the integration. This yields:

By using the Reynolds transport theorem, the two previous equations can be expressed in a space fixed volume, shown in Figure 2. Performing this conversion results in the following equations:

$$\frac{\mathcal{B}_{\mathsf{d}}}{\mathsf{d}t} \int_{\mathsf{Body}} \mathbf{r}_{M/B} \, \mathsf{d}m = \frac{\mathcal{B}_{\mathsf{d}}}{\mathsf{d}t} \int_{\mathcal{V}_{\mathsf{sc}}} \rho \, \mathbf{r}_{M/B} \, \mathsf{d}\mathcal{V} + \int_{\mathcal{A}_{\mathsf{sc}}} \rho \, \mathbf{r}'_{M/B} \cdot \hat{\mathbf{n}} \, \mathbf{r}_{M/B} \, \mathsf{d}A \tag{13}$$

$$\frac{{}^{\mathcal{B}}\mathsf{d}^{2}}{\mathsf{d}t^{2}} \int_{\mathsf{Body}} \boldsymbol{r}_{M/B} \,\mathsf{d}m = \frac{{}^{\mathcal{B}}\mathsf{d}^{2}}{\mathsf{d}t^{2}} \int_{\mathcal{V}_{\mathsf{sc}}} \rho \, \boldsymbol{r}_{M/B} \,\mathsf{d}\mathcal{V} + \frac{{}^{\mathcal{B}}\mathsf{d}}{\mathsf{d}t} \int_{\mathcal{A}_{\mathsf{sc}}} \rho \, \boldsymbol{r}_{M/B}' \cdot \hat{\boldsymbol{n}} \, \boldsymbol{r}_{M/B} \,\mathsf{d}A + \int_{\mathcal{A}_{\mathsf{sc}}} \rho \, \boldsymbol{r}_{M/B}' \cdot \hat{\boldsymbol{n}} \, \boldsymbol{r}_{M/B}' \,\mathsf{d}A \quad (14)$$

where $v_{\text{rel}} = r'_{M/B}$ because point B is fixed with respect to the spacecraft. Equation (10) is reorganized by using the previous relations in order to convert it to an Eulerian approach, i.e. based on a volume-based derivation:

$$\int_{\mathsf{Body}} \left(\ddot{\boldsymbol{r}}_{B/N} + \dot{\boldsymbol{\omega}}_{B/N} \times \boldsymbol{r}_{M/B} + \boldsymbol{\omega}_{B/N} \times \left(\boldsymbol{\omega}_{B/N} \times \boldsymbol{r}_{M/B} \right) \right) \mathrm{d}\boldsymbol{m} + 2 \,\boldsymbol{\omega}_{B/N} \times \left(\frac{\mathcal{B}_{\mathsf{d}}}{\mathrm{d}t} \int_{\mathcal{V}_{\mathsf{sc}}} \rho \, \boldsymbol{r}_{M/B} \, \mathrm{d}\mathcal{V} + \int_{\mathcal{A}_{\mathsf{sc}}} \rho \, \boldsymbol{r}'_{M/B} \cdot \hat{\boldsymbol{n}} \, \boldsymbol{r}_{M/B} \mathrm{d}A \right) \\ + \frac{\mathcal{B}_{\mathsf{d}}}{\mathrm{d}t} \int_{\mathcal{A}_{\mathsf{sc}}} \rho \, \boldsymbol{r}'_{M/B} \cdot \hat{\boldsymbol{n}} \, \boldsymbol{r}_{M/B} \, \mathrm{d}A + \int_{\mathcal{A}_{\mathsf{sc}}} \rho \, \boldsymbol{r}'_{M/B} \, \mathrm{d}A = \boldsymbol{F}_{\mathsf{ext}}$$

As explained in previous work, if all of the mass is contained in the control volume at the initial time, then a particular relation results because no mass is outside the control volume at t = 0 and the

dynamic quantities will be transported out during the integration. This relationship is quantified in the following equation:

$$\begin{aligned} F_{\text{ext}} - \int_{\text{Body}} \left(\ddot{r}_{B/N} + \dot{\omega}_{B/N} \times r_{M/B} + \omega_{B/N} \times \left(\omega_{B/N} \times r_{M/B} \right) \right) \mathrm{d}m &= \int_{\mathcal{V}_{\text{sc}}} \mathrm{d}F_{\text{vol}} + \\ &+ \int_{\mathcal{A}_{\text{sc}}} \mathrm{d}F_{\text{surf}} - \int_{\mathcal{V}_{\text{sc}}} \rho \left(\ddot{r}_{B/N} + \dot{\omega}_{B/N} \times r_{M/B} + \omega_{B/N} \times \left(\omega_{B/N} \times r_{M/B} \right) \right) \mathrm{d}\mathcal{V} \end{aligned}$$

where the forces are divided into volumetric forces and the forces applied on the spacecraft surface. Rearranging this result, replacing the definition of F_{ext} , and isolating the forces to the right hand side of the equation yields:

$$\int_{\mathcal{V}_{sc}} \rho \left(\ddot{\boldsymbol{r}}_{B/N} + \dot{\boldsymbol{\omega}}_{B/N} \times \boldsymbol{r}_{M/B} + \boldsymbol{\omega}_{B/N} \times \left(\boldsymbol{\omega}_{B/N} \times \boldsymbol{r}_{M/B} \right) \right) d\mathcal{V} + \\ + 2 \,\boldsymbol{\omega}_{B/N} \times \left(\frac{\mathcal{B}_{d}}{dt} \int_{\mathcal{V}_{sc}} \rho \, \boldsymbol{r}_{M/B} \, d\mathcal{V} + \int_{\mathcal{A}_{sc}} \rho \, \boldsymbol{r}'_{M/B} \cdot \hat{\boldsymbol{n}} \, \boldsymbol{r}_{M/B} \, dA \right) + \frac{\mathcal{B}_{d}^{2}}{dt^{2}} \int_{\mathcal{V}_{sc}} \rho \, \boldsymbol{r}_{M/B} \, d\mathcal{V} + \\ + \frac{\mathcal{B}_{d}}{dt} \int_{\mathcal{A}_{sc}} \rho \, \boldsymbol{r}'_{M/B} \cdot \hat{\boldsymbol{n}} \, \boldsymbol{r}_{M/B} \, dA + \int_{\mathcal{A}_{sc}} \rho \, \boldsymbol{r}'_{M/B} \cdot \hat{\boldsymbol{n}} \, \boldsymbol{r}'_{M/B} \, dA = \int_{\mathcal{V}_{sc}} d\boldsymbol{F}_{vol} + \int_{\mathcal{A}_{sc}} d\boldsymbol{F}_{surf} \quad (17)$$

One goal for this paper is to develop the EOMs of a spacecraft with depleting mass without the necessity of continuing to track the depleted mass once it has left the spacecraft. One aspect of achieving this goal, is to define the center of mass of the spacecraft with respect to point B, including the remaining fuel while disregarding the spent fuel. This variable, $c = r_{C/B}$, is defined as:

$$\boldsymbol{c} = \frac{m_{\mathsf{hub}} \, \boldsymbol{r}_{Bc/B} + \sum_{i=1}^{M} m_{\mathsf{fuel}_i} \, \boldsymbol{r}_{Fc_i/B}}{m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_i}} \tag{18}$$

where m_{hub} is the mass of the hub, m_{fuel_i} is the i-th tank's fuel mass and $r_{Fc_i/B}$ is the position of the center of mass of the i-th tank's fuel. In order to infer the influence of the mass variation in the EOMs equation of motion the first and second time derivatives with respect to the body frame of c is defined:

$$c'' = \frac{\sum_{i=1}^{M} \left(\ddot{m}_{\mathsf{fuel}_{i}} \boldsymbol{r}_{Fc_{i}/B} + 2 \, \dot{m}_{\mathsf{fuel}_{i}} \boldsymbol{r}_{Fc_{i}/B}' + m_{\mathsf{fuel}_{i}} \boldsymbol{r}_{Fc_{i}/B}' \right)}{m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_{i}}} + \frac{m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_{i}}}{\left(m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_{i}} \right)^{2}} + \frac{\left(\sum_{i=1}^{M} \dot{m}_{\mathsf{fuel}_{i}} \right) \left(\sum_{i=1}^{M} \left(\dot{m}_{\mathsf{fuel}_{i}} \boldsymbol{r}_{Fc_{i}/B} + m_{\mathsf{fuel}_{i}} \boldsymbol{r}_{Fc_{i}/B} \right)}{\left(m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_{i}} \right)^{2}} + \frac{2 \left(\sum_{i=1}^{M} \dot{m}_{\mathsf{fuel}_{i}} \right)^{2} \left(m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_{i}} \right)^{2}}{\left(m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_{i}} \right)^{2}} \right)} + \frac{2 \left(\sum_{i=1}^{M} \dot{m}_{\mathsf{fuel}_{i}} \right)^{2} \left(m_{\mathsf{hub}} + \sum_{i=1}^{M} m_{\mathsf{fuel}_{i}} \right)^{3}} \right) (20)$$

Using these definitions of c, the translational EOM can be simplified. Additionally, some assumptions need to be defined to further simplify the translational EOM. The hub is assumed to be rigid, therefore deformations are not considered. The mass flow within the tanks and the thrusters is assumed to be a second order effect and ignored for this paper. The particles are assumed to be accelerated instantaneously from the spacecraft velocity, $\dot{r}_{B/N}$, to the exhausted velocity v_{exh} at the nozzle. And the exhausted velocity v_{exh} is considered constant and parallel to the nozzle's normal \hat{n} .

The first integral in Eqn. (17) is computed using the fact that $r_{M/B} = c + r_{M/C}$ and the result is shown in the following equation:

where $m_{sc} = m_{hub} + \sum_{i=1}^{M} m_{fuel_i}$ is the instantaneous mass of the spacecraft. The second and fourth integrals are computed and yield:

where $\dot{m}_{\text{fuel}} = \sum_{i=1}^{M} \dot{m}_{\text{fuel}_i}$ and $\ddot{m}_{\text{fuel}} = \sum_{i=1}^{M} \ddot{m}_{\text{fuel}_i}$.

In order to find the term calculated on the reference surface seen in the third, fifth and sixth integrals, it is convenient to separate the integrals on the surface of each nozzle. Moreover, as the fuel's properties are flowing out of a surface plane, it is convenient to consider that $r_{M/B} = r_{M/Fc_j} + r_{Fc_j/B}$ where Fc_i is the area's geometric center. Finally, an appropriate variable transformation is given in Eqn. (4). Performing these calculations on the third integral results in:

This EOM is the translational equation for an open system subjected to external forces $F_{\text{ext, vol}}$ and $F_{\text{ext, surf}}$ and thrust $F_{\text{thr}} = \sum_{j=1}^{N} F_{\text{thr}_j}$ due to mass depletion of the spacecraft, represented in Figure 1. From this equation, it can be deduced that the variation of the mass inside the spacecraft directly impacts the position of the satellite with respect to the origin as the body fixed point B changes its state of motion according to the variation of the tanks' linear inertia. In the next section, the rotational EOM for the spacecraft is developed.

1.2.3 Rotational Equation of Motion

The goal of this section is to develop the EOM associated with attitude dynamics of a spacecraft with depleting mass due to thrusters pulling mass from fuel tanks. Beginning from Newton's equation:

It should be noted here that any relative motion of particles inside the fuel tanks of the spacecraft has been neglected and, as a consequence, the effects both of the Coriolis' acceleration and of the whirling motion of the fuel on the spacecraft dynamics have not been considered.

Additionally, the inertial time derivate of the vectors $r_{Bc/B}$ and $r_{Fc_i/B}$ is computed using the transport theorem between the two reference frames given in Equations (8) and (9) and, considering that the point B_c is fixed in the \mathcal{B} frame, Equation (40) is rewritten:

Finally the rotational EOM is written as:

This concludes the derivation of the EOMs needed to describe the translational and rotational motion of a spacecraft with depleting mass due to thrusters. The following section describes the models used for the fuel tanks.

1.3 Tank models

Different tank models could be developed to perfectly suit the needs of the spacecraft's fuel chain configuration. In the present paper five reservoir models will be considered as examples and their properties, such as inertia variation and barycenter motion, will be gathered. The models and their main hypothesis are presented below:

- The constant tank's volume model where a spherical reservoir maintains a fixed geometry, i.e. a constant radius, and a fixed barycenter.
- The constant fuel's density model where a spherical tank keeps its geometrical shape but gradually change its volume, so its radius, to maintain constant the density of the fuel and it has a fixed center of mass.

- The emptying tank model where the fuel leaks out from an outlet in the spherical reservoir and the quantity of fuel decrease perpendicularly to the output direction modifying the barycenter position and the body's inertia accordingly to the mass distribution inside the tank.
- The uniform burn cylinder model where a cylindrical tank does not change its geometrical shape and volume but the gas gradually decrease its density. As a consequence, the fuel barycenter remains fixed and the inertia varies accordingly to the mass variation.
- The centrifugal burn cylinder model where a cylindrical tank is considered and the fuel burns radially from the center until the walls without breaking the tank's symmetry. The inertia tensor derivative is computed from these hypothesis and the barycenter remains in its initial position because the symmetry is conserved.

1.3.1 The constant tank's volume model

This model takes into account the variation of the fuel inside considering no variation of the volume off the tank. By looking at Figure 3:

1.3.3 The emptying tank model

In this case the mass variation stats from the opposite point to the outlet, that will be called from now on the pole, perpendicularly to the vector connecting the pole and the outlet.

The following notation will be used: $\theta \in (0, \pi)$ will be the latitude angle counted from the pole till the outlet, $\phi \in (0, 2\pi)$ will note the longitude angle, the radius will be $r \in (0, R_{tank})$. Moreover the θ^* will denote the angle between the pole and the circumference of the fuel's free surface. The volume \mathcal{V} and the center of mass of the tank can be computed using notations in figure 5:

1.3.4 Uniform burn cylinder

This model consider a cylindrical tank whose geometry remains constant while fuel density changes. From these considerations and by looking at Figure 6, the inertia tensor and its derivative could be

1.3.5 Centrifugal burn cylinder

The present model consider a cylinder filled with propellant burning radially from the center to the edge. The geometry properties and their nomenclature can be seen in Figure 7.

By denoting r the distance of the fuel surface from the axis of the cylinder, this quantity can be easily computed from the amount of mass in the tank:

Finally, the tank's center of mass does not move as the mass variation is symmetric. Thus:

$$r'_{Tc/B} = 0$$
 $r''_{Tc/B} = 0$ (86)

1.4 Update-Only Equations

Eqs.(31) and (88) are the translational and rotational EOMs for the fully coupled dynamics of mass depletion. However, it is common to use an "update-only" method for mass depletion which does not consider mass depletion as a dynamical effect. In contrast to the fully coupled model it simply updates the mass properties of the spacecraft. The equations for the "update-only" can be simplified to:

$$m_{\mathsf{sc}}\left[\tilde{c}\right]\ddot{r}_{B/N} + \left[I_{\mathsf{sc}, B}\right]\dot{\omega}_{\mathcal{B}/\mathcal{N}} = -\left[\tilde{\omega}_{\mathcal{B}/\mathcal{N}}\right]\left[I_{\mathsf{sc}, B}\right]\omega_{\mathcal{B}/\mathcal{N}} + L_B + \sum_{j=1}^{N} L_{B_{\mathsf{thr}_j}}$$

2 Model Functions

This module is considered a fuel tank effector attached to a rigid body hub and has the following functions:

- Compute tank properties depending on the tank model being used
- Provides its contributions to the mass properties of the spacecraft

- Provides its contributions to the back-substitution matrices
- Computes its derivative for its mass flow rate using the vector of attached thrusters
- Provides its contributions to energy and momentum of the spacecraft

3 Model Assumptions and Limitations

Below is a summary of the assumptions/limitations:

- There can be no relative rotational motion between the fuel in the tank and rigid body hub
- The thrusters can be vectored but rather need to be fixed with respect to the rigid body hub
- There is no relative rotational motion between the mass leaving the spacecraft through the thrusters and the rigid body hub
- The movement of the mass between tanks and thrusters is not considered as a dynamical effect (i.e. the motion of the mass through piping in the spacecraft)
- Fuel slosh is not being considered by this module alone, however fuel slosh can be attached to the spacecraft by using the *fuelSloshParticle* effector
- The mass and inertia of the fuel tank is not included in the rigid body mass when setting up a simulation, but rather the fuel tank mass properties is added to the spacecraft dynamically during the simulation

4 Test Description and Success Criteria

The two tests are located in simulation/dynamics/FuelTank/_UnitTest/ test_tank_models.py and simulation/dynamics/FuelTank/_UnitTest/ test_mass_depletion.py. Depending on the scenario, there are different success criteria. These are outlined in the following subsections:

4.1 Update Only Integrated Test

The update only integrated test is confirming that identical results are achieved compared to the old architecture's position and attitude outputs. The tests are successful the position and attitude values agree to with a specified tolerance.

4.2 Tank Model Unit Tests

The tank model unit tests computes the tank properties in python and compares those values that are outputted in Basilisk. The success criteria is confirming that $\left[I'_{\text{fuel}_{i},B}\right]$ and $r'_{T_{c}/B}$ for both python and Basilisk agree within a specified tolerance.
